

### JACKALOPE CLUB - RULES OF CONDUCT

1. Members must sign the Register upon entering the Clubroom;
2. Only members in good standing and their registered guests are permitted access to the Clubroom;
3. Members must make every effort to ensure that their guests are familiar with and comply with the Jackalope Club's **Rules of Conduct**;
4. Members may be accompanied by up to four guests at any one time. All guests of a member must be signed in by the responsible member;
5. Registered guests must leave the Clubroom when the responsible member leaves for the evening;
6. Minors (under 19 years of age) must be accompanied at all times and supervised by a parent or other responsible adult when they are in the Clubroom;
7. Minors must leave the Clubroom on or before 10:00p.m.;
8. Smoking is prohibited inside the Marsh Lake Community Center;
9. Bringing alcoholic beverages into the Clubroom from outside the Clubroom is prohibited;
10. Taking alcoholic beverages outside the Club room is prohibited;
11. No member or his/her guests shall use obscene language or exhibit loud, disruptive, disorderly or aggressive behaviour towards staff, other members or guests while in the Club room;
12. No member shall supply alcohol of any kind to a minor;
13. No member shall exhibit drunkenness inside the Club room;
14. Gambling is prohibited;
15. Members or their guests who breach the Club's **RULES OF CONDUCT** may be asked to leave the Club room by the Bartender;
16. Subject to rule 19, a breach of any of the Rules of Conduct may, in the discretion of the Club room Manager, be the subject of a formal written complaint to the Board of Directors of the Marsh Lake Community Society;
17. If asked to leave the Clubroom under rule 15, the member and/or his/her guests shall do so immediately and without complaint;
18. Where a person or persons have been ejected from the Club room under rule 15 they shall leave the Marsh Lake Community Center grounds and not return for a period of 24 hours;

19. A member or his/her guest(s) who has been asked to leave the Club room under rule 15 and refuses or neglects to do so, or returns to the Community Center in violation of rule 18 shall be the subject of a formal written complaint to the Board of Directors of the Marsh Lake Community Society;
20. Upon receipt of a complaint under rule 16 or 19 the Board of Directors shall hold a hearing into the complaint at any time after 14 days written notice to the member whose behavior is the subject of the complaint;
21. If the member under complaint fails to appear for the hearing after being duly notified, the hearing may proceed in his or her absence;
22. Where a complaint is lodged against a member, their membership in the Jackalope Club is suspended until the conclusion of the breach hearing by the Board of Directors;
23. A person accused of a breach of these rules, has the right to make full answer and defence at the breach hearing;
24. Where the Board of Directors has determined that a member has breached these rules of conduct, the Board may, if the complaint is made under rule 16:
  - a. Revoke the membership or;
  - b. Suspend the membership for a period of up to six months;
25. Where the Board of Directors finds that a member has breached rule 19, the Board of Directors shall revoke the membership;
26. A person whose membership has been revoked may not thereafter be admitted to membership in the Jackalope Club without the unanimous consent of the Board of Directors of the Marsh Lake Community Society;
